Membership Details:

- The Membership will run from date of inception/renewal until the end of March 2027 and billed in a single payment on the date of approval.
- The Cost of membership will be \$3,250.00 for the primary member.
 - Neighbors of GNGC will receive a discount of \$250.00 and must currently reside at the address
 - A Spouse/Partner residing at the same address may be added to the membership at a cost of \$2,000.00.
 - A child (18 and under) residing in the same residence may be added to the membership at a cost of \$1,200.00.
- There will be no Memberships sold after March 31, 2026. Any current Member who expires after this date and wishes to renew before membership ends on March 31st, will receive a pro-rated discount from their existing membership from March 31, 2026, until the date their current membership expires.
- There will be a limit of 50 memberships of all types available while registration is open until March 31, 2026.

Benefits:

- Members will receive free range balls at any time they are playing or practicing at the course. This is for members only and does not extend to their guests. Any member who abuses this privilege may have it revoked at the discretion of Management and/or Ownership without reimbursement.

- 15% off regularly priced apparel in the Golf Shop.
- Special Member pricing when entering Club Tournaments.
 - Member must pay cart fees, prize pot money, and food and beverage charges established for any scheduled tournament or special event.

Greensboro National will be closed for tournaments at the sole discretion of the Management Staff at GNGC. _____

Members who have repeated violations or infractions, major or minor, will expect discipline imposed from Management and Ownership. This discipline could be suspension or termination of membership privileges without reimbursement. _____
