



## Clubhouse and Golf Course Rules and Regulations

It is our goal to make Greensboro National a destination golf course in the Triad that will promote the economic development of Rockingham County as well as our neighbors at Greensboro National and in Northern Guilford County. Please take a moment to review the following.

1. USGA Rules of Golf will govern all play except when modified by local rules. The Golf Professional and the professional staff will determine the rules and regulations of all Club tournament events. Information regarding Club tournament events shall be provided in writing to all competitors.
2. The Golf Professional Staff shall have full authority to regulate play on the golf course always.
3. The Golf Course Operations Manager, or in their absence, the Head Golf Professional, shall have full authority to restrict or prohibit play due to weather, course conditions or general maintenance.
4. Slow play is inexcusable. It is expected that a round of golf shall not exceed four hours and fifteen minutes. If a complete hole is open ahead of a group, Golf Staff will ask the group to exercise one of the following options:
  - a. Close the gap and maintain that position
  - b. Step aside and let the faster groups play through before resuming play
  - c. Skip the next tee shot, move forward, tee up and begin play at the 150-yard marker and maintain this position.
  - d. If a group is unable to keep up with the normal pace of play, they will be asked to leave the golf course and any fees collected will be refunded on a pro-rated basis.
5. Practice will be limited to designated areas only. A player may not play more than one ball to a green unless it is defined in a tournament as a mulligan hole.
6. All players, members and guests must check-in and register in the Golf Shop before beginning play. Each player's name must appear on the tee sheet.
7. All play must commence from the #1 tee unless otherwise authorized by the Club Staff. Starting on a hole other than #1 does not guarantee the right to immediately begin on the first tee at the turn. Players who stop at the Golf Snack Bar may forfeit their position on #10 tee if there is a delay.
8. Each person playing golf shall be equipped with a set of golf clubs and dressed in acceptable golf attire. Acceptable attire will include:
  - a. a collared shirt with sleeves, mock turtlenecks, long or short sleeved and tailored slacks or shorts.
  - b. Women may wear acceptable length tailored shorts, slacks, skirts and capris.
  - c. Unacceptable attire shall include, but is not limited to: tee shirts, swim suits, sweat shirts, running shorts, gym shorts, blue jeans, cut off pants, tank tops and halter tops. Each golfer must wear soft spikes or soft soled athletic shoes.
9. Starting times are required for all players. Tee times may be reserved two weeks in advance and will require the names of each player. Golfers who arrive late for their assigned tee time will be given the next available time.



10. For safety purposes and the general consideration of all golfers, children will not be allowed on the golf course, unless they are playing golf under the requirements set forth in the section regarding Junior Golf Rules.
  - a. Non-certified juniors can use the driving range, putting green and practice area if they are accompanied and supervised by a parent or member of the Golf Professional Staff.
  - b. Juniors are subject to the Club's rules and regulations.
  - c. Juniors under the age of 12 should never be left unattended in the golf or practice areas.
11. A Starter/Marshal shall be utilized, as needed, to expedite play, to enforce golf etiquette and general golf rules and regulations. It is the obligation of each golfer to comply with these directions.
12. Golfers participating in Club handicap events must have a USGA handicap. The maximum handicap allowed in such an event will be 36 for men and 40 for women. Some events may, per USGA, require a reduction of handicap. The Professional Staff has the right to adjust handicaps for equity.
13. A Junior (a golfer under 18 years of age) is not allowed to play in Club sponsored golf tournaments unless the event is sanctioned as a Junior Tournament.
14. Management approved golf tournaments and scheduled Club events have priority over all other play on the golf course.
15. Only food and beverage provided by the Club is permitted on the golf course. It is against Club policies to bring coolers on Club property. It is illegal to bring alcoholic beverages onto Club property or to remove them from Club property.
16. Walking, jogging, or bicycling is not permitted on the golf course.
17. Offensive language or actions unbecoming of a golfer will not be tolerated and may result in suspension of a member's club use and/or playing privileges.
18. The Club shall not be responsible for any loss, theft, or damage to any property of any kind belonging to members or their guests.
19. Inclement Weather:
  - a. Play of five (5) holes or more constitutes a nine (9) hole round
  - b. Play of thirteen (13) holes or more constitutes an eighteen (18) hole round.
  - c. Refunds of cart or guest fees in situations where inclement weather becomes an issue will be issued under these guidelines.
20. Natural or Unforeseen Circumstances:

In the event of a natural uncontrollable occurrence that causes damage to the course, specifically to the greens, Greensboro National will not be responsible for issuing any credit towards membership for lost time.
21. On the first of each month, Payment is due **in Full** on any outstanding charges on a Member's account. Failure to pay within 30 days will result in suspension of membership until rectified.

## Private Cart Rules

Greensboro National Golf Club LLC(GNGC) will allow the continuing use of certain registered private golf carts on the golf course property until the close of GNGC business on December 31, 2019, under the following rules and conditions:

- 1) All private golf cart owners must be a current resident of the Greensboro National subdivision or certain approved adjacent properties.
- 2) All private golf cart owners on GNGC property must register their respective golf cart with GNGC, receive a GNGC decal that must be conspicuously displayed and comply with the following:
  - i. Proof of insurance filed with the Golf Shop, indicating that GNGC is co-insured for a minimum of \$1,000,000 coverage per loss, and all premiums for such insurance will be the responsibility of the private cart owners.
  - ii. Annual Cart Plans and Membership rates will apply and must be paid in advance of any use on GNGC property. **This includes \$25 Permit Fee for Decal**
  - iii. Private cart owners must maintain an active membership or cart plan and remain current on all charges related thereto. Failure to do so will result in suspension of private cart use until account is made current.
  - iv. GNGC course and cart rules must be adhered to by cart drivers on the course. Violators will forfeit all fees and playing privileges GNGC will be revoked indefinitely.
- 3) Check-in with the Golf Shop before playing is required for all golf rounds/holes played.
- 4) A designated parking area will be provided for private cart owners who are NOT part of a cart plan.
- 5) Private carts will not be permitted to use the golf club's cart facility for any reason (such as cleaning, repairs, charging, etc.)
- 6) All repairs and maintenance of private carts will be the responsibility of the cart owner.
- 7) Effective **January 1, 2020** private carts will no longer be permitted for use at GNGC.
- 8) **All private cart operators must have a valid Drivers License while on GNGC property.**
