Our pool has been converted from chlorine to saltwater. Saltwater pools promote healthier breathing, relieve sore muscles, reduce stress and anxiety, and are gentler on skin, hair, and eyes.

A Greensboro National Golf Club (GNGC) Staff Member will be at the pool every day to monitor the use of membership and ensure only listed members have access to the pool. Any guests are welcome to join our pool members for just \$5 per guest each day they accompany the member.

A Pool Attendant will be available Fridays, Saturdays, and Sundays (hours will vary based on occupancy, staffing availability, and weather)

Pool members ordering food while using the pool must do so via the Tavern QR code or by calling the Tavern to place an order on days when a pool attendant is unavailable.

Pool Members and Guests are NOT permitted in the pool area outside of the stated times.

___ I understand that this application is for a single household and that all the above stated adults and dependents live in the above stated residence. Any individuals that do not live at the above stated residence, regardless of relationship to the primary or additional members, will not be accepted to the pool area without a guest fee being applied.

___ I understand outside alcohol is not permitted on the property. (N.C. Gen. Stat. § 18B-301 & related provisions): Under North Carolina law, as the operator of this facility, Greensboro National Golf Club has the authority to establish rules governing items brought onto the premises, including prohibiting outside food and beverages. These policies also support compliance with North Carolina ABC regulations for permitted establishments.

___ I understand all outside coolers and bags are subject to inspection by course staff prior to pool property entry. This policy is to ensure compliance with course rules, including outside alcohol, food, and beverage items prohibited, and safety regulations. By entering the property, all guests agree to comply with any such inspections. Failure to comply may result in cancellation of membership without refund.

____ I have received and read over the GNGC Rules and Regulations and agree to abide by those rules and regulations. Any violation of the rules and regulations can result in the suspension or termination of the membership, with no refund, or the suspension or termination of an individual(s) on a specified membership.

Release of Liability: In consideration of being allowed to participate in any way in the program of related events, and activities, I, the under signer, acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program is significant, including potential for permanent paralysis or death.
2. Knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releases of others and assume full responsibility of my participation.
